Where the singular word "SUBLESSOR" or "SUBLESSEE" is used herein it shall be construed as meaning each and every person signing this Sublease Agreement as SUBLESSOR or SUBLESSEE respectively, jointly and severally. The obligations hereunder shall be joint and several as to each such person. The actions and/or omissions of any such person shall be construed against each and every person signing this Sublease Agreement.

2. SUBLESSOR agrees to lease to SUBLESSEE the premises described in the attached APARTMENT RENTAL AGREEMENT (hereinafter referred to as "RENTAL AGREEMENT are incorporated herein by reference. SUBLESSEE acknowledges that he has read all terms, provisions and covenants of said RENTAL AGREEMENT and understands the same. Further, SUBLESSEE agrees to abide by the terms of said RENTAL AGREEMENT. It is further understood and agreed that the SUBLESSOR is fully responsible for all of the rents and obligations required in said RENTAL AGREEMENT.
